This document is important and we request your immediate attention.

Increased use of electronic communications will deliver savings to the Club in terms of administration, printing and postage costs, as well as speeding up the provision of information to members. The reduced use of paper will also have environmental benefits. It is our intention to utilise electronic communication with members as much as possible and are requesting your individual agreement thereto.

Therefore, if you agree to the Company sending or supplying the Documents or Information to you via the Website, you need take no further action in relation to this part of the letter. If you would prefer to receive the Documents and Information in paper form rather than via the Website, you will need to let us know by completing the reply slip at the end of this letter and returning it to the Company at the above address.

We will notify you when Documents and Information are available to access on the Website.

Please can you also confirm your agreement to the Company corresponding with and sending or supplying the Documents and Information to you in electronic form. If you agree to this, please provide your email address for these purposes even if you have provided it before so that we can ensure that our records are up to date.

Please note that there may be particular circumstances in which the Company needs to send Documents or Information to you in hard copy rather than by Website or email, in which case the Company reserves the right to do so.

Should you wish to cease receiving documents by Website or email at any time then please notify the Club Secretary.

Please detach the reply slip below, sign and return it to the Club at the above address, indicating your consent to the Company corresponding with and sending or supplying the Documents and Information to you in electronic form (in accordance with paragraph 6 of Schedule 5 to the Companies Act 2006). Please also provide details of your email address for this purpose in the space provided on the reply slip.
